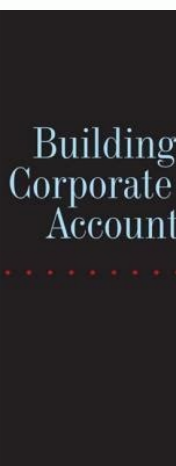
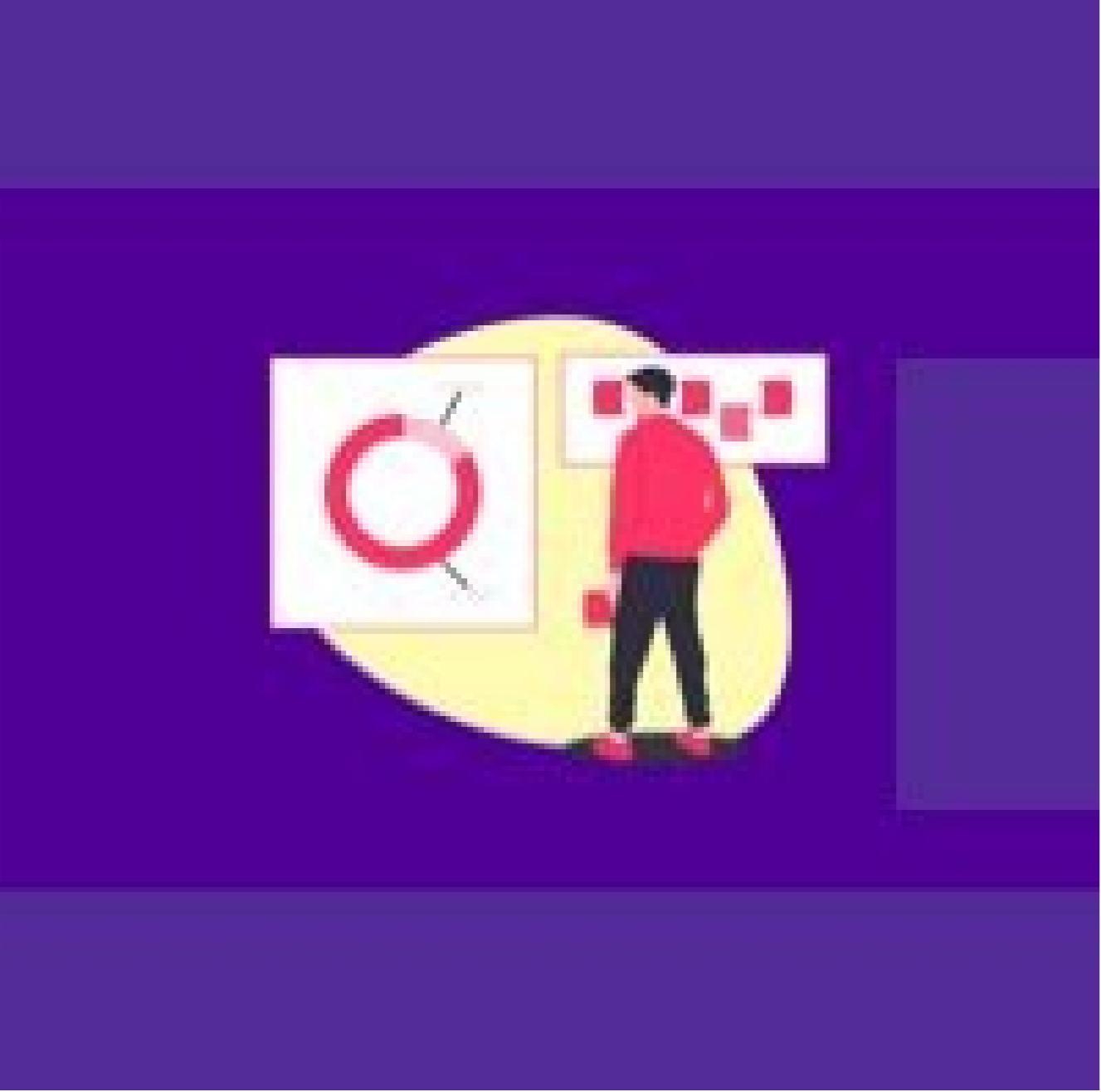

Such expenses must still be reported on an Expense Report (APY 005 or APY 015) or Employee Reimbursement Form. The signed original log must be attached and submitted with the Expense Report or Employee Reimbursement Form.
